3. The rates will be valid till **30<sup>th</sup> June 2022** extendable further.
4. Bidding documents can be obtained from Burns & Plastic Surgery Centre Hayatabad Peshawar during office hours before the Tender Opening or downloaded from official website [www.btckp.gov.pk](http://www.btckp.gov.pk).
5. Only typed tender on original company prescribing letter pad, sealed & signed (Every Page) should be submitted in words & figures.
6. Bids must be delivered at the address given below at or before **10:00 AM on Wednesday, 16/02/2022**, which will be opened in the presence of the bidders or their authorized representatives on the same day at **11:00 AM** by Tender Opening Committee.
7. Any bids received after due date & time shall be rejected as per KPPRA rules.
8. Proprietary Certificate if applicable must be attached.
9. The firm must be on FBR Active Tax payer list, taxes will be deducted as per rules. The firms must provide detail on NTN #, Sales Tax #, Income Tax #, professional Tax # etc and exemption if any.
10. The bidder will be bound to ensure the fulfillment of the said order within stipulated period as per supply order, otherwise penalty will imposed as per Govt: rules. The competent authority reserves the right to extend the work order period on mutual understanding if needed.
11. No conditional tender will be acceptable.
12. Bid Security shall be in the form of CDR in favor of **Director Burn and Trauma Centre** Peshawar.
13. The detailed terms & Conditions will be incorporated in the bidding documents.

However after bid opening no alteration in bid documents shall be allowed.
7. If a bid is not substantially responsive, it will be rejected for the said bidding.
8. B&TC Peshawar may accept or reject any or all of the bids under Rule 47 of KPPRA Rules, 2014.
9. The successful bidder shall provide bill of lading on shipment, insurance document, if applicable.
